CHEEKIITOWAN OURSOVERIENGTY

The Morongo Band of Mission Indians is a federally recognized Indian tribe located adjacent to the City of Banning within Riverside County, California. The Tribe has approximately 750 enrolled members and the land base consists of close to 32,000 acres located about 20 miles west of Palm Springs.

The Morongo Tribal Court, created by the Morongo Tribal Council, began hearing cases in October of 2007.

The Court hears those types of cases delegated to it by the Council.

Presently, the Court hears matters arising under Tribal laws governing child protection, ordinance violations, tort liability and patron Claims, guardianships and disabled adult conservatorships.





COMMON CASES

GUARDIANSHIPS

A Petition for Guardianship is a court process by which a person other than the parent is given custody of a child.

The Tribal Court has jurisdiction to oversee guardianship proceedings over Members and First
Descendants who reside on the Morongo Indian Reservation.

CONSERVATORSHIPS

The Morongo Tribal Court may appoint guardians for the persons and/or the estates of incapacitated persons. A person, including a close or extended family member, may petition the Tribal Court to appoint a Conservatee who will provide care and protection to an incapacitated Tribal Member.
